#### GENERAL POLICIES

The following regulations pertain to more than one activity, and therefore are included at the beginning of the Region 15 Activity Manual. Specific regulations for each sport or activity will be found with the Region 15 schedule for that activity. All state wide regulations can be found in the UHSAA Handbook, or on the UHSAA website ([www.uhsaa.org](http://www.uhsaa.org)). It is the responsibility of all principals, coaches, moderators and participants to become thoroughly familiar with these regulations.

### **DUTIES OF OFFICERS AND MEMBERS**

#### **CHAIRMAN OF THE BOARD**

1. General administration of board policies and decisions.
2. Prepare agenda and conduct board meetings.
3. Act as official representatives of the Region when appropriate.

#### **MEMBERS**

1. Member's schools and districts are financially responsible for activities sponsored by the Region.
2. Members will individually support collective decisions made by the Region Board.
3. Will serve as activity chairman and committee members.
4. Member region schools will have annual membership dues in the amount of \$3500, or as determined



annually be the Board.

## **MEETINGS**

Meeting sites and dates will be selected by the Board. It is recommended that meetings be held monthly. It is also recommended that meetings be held at a central location.

## **AGENDA**

The agenda will follow the format below:

- A. Call to order
- B. Presentation of previous minutes for approval or discussion
- C. Presentation of the financial statement for approval or discussion
- D. Report from UHSAA Representatives: Board of Trustees; Executive Committee
- E. Action Items-Items that require either a general consensus or vote by the Board
- F. Discussion Items-Informational items that do not require action, to include Athletic Director's reports.

## **ORGANIZATION OF THE ACTIVITIES**

Each program's Activity Chairmen for the next year is responsible for presenting a proposed schedule for that activity early enough that changes may be made by the Board. Committee members may be appointed by the Board Chairman to assist when necessary. Activity Chairmen are responsible for all aspects of the activity they are selected to supervise. The chairman will report to the Board at the conclusion of the activity.

Activity Chairmen will evaluate the procedures and practices of the activity for which they are responsible.

They may meet with coaches and advisors of those activities for the purpose of reviewing, revising, and setting new schedules. It is recommended that this meeting take place soon after the culminating State activity so that the Chairman can report to the Board at the next regularly scheduled meeting. Adjustments and improvements will be made as needed. Eligibility of participating students must follow the guidelines of the current UHSAA Handbook.

All schools are expected to provide competent, adult scorers, timers, line callers, chain crews, etc. for all varsity events; they are officials, not spectators in behavior.

Schedule changes must be acceptable to both schools (coaches and principals). The Region Chair may conduct a survey of Region members by phone or email for decisions immediately needing action.

## **VIDEO AND VENDING POLICY**

Region 15 prohibits the use of filming and/or video taping of Region 15 sponsored activities for commercial purposes. Exchange of a standard football game tape by opposing schools will be done one week before game time or as determined by the coaches involved.

-Video taping or filming is allowed and encouraged by each school involved in a contest, but may not be used for scouting purposes during that contest.

-Video taping or filming of games and/or tournaments by other schools, coaches, or patrons for scouting purposes, when not involved in that specific match or tournament is prohibited.

Region 15 *restricts* "special request" vending at activities unless approved by the Region Board. *An approved vend requires a minimum of \$100/day or highest bid for service.*

## **PROTEST PROCEDURE**

In the event that a school wishes to lodge a protest in connection with any activity, the procedures published in the current Utah High School Activities Association Handbook will be followed. A protest will be official when completed in writing and signed.

## **HOSPITALITY ROOM PROCEDURES**

Region 15 does not require member schools hosting region tournaments to sponsor a hospitality room. That decision is left to the individual school administration; however, Region 15 will reimburse schools hosting tournaments for boys and girls basketball, wrestling, and volleyball, up to \$400 per day at the approved tournament. Funding for the hospitality room beyond that level shall be the responsibility of the host school. The Region 15 Board of Managers will determine final amounts and circumstances.

## **20 HOUR PRACTICE RULE**

In order to protect study and recreational time for students and parents, Region 15 requires that no High School Athletic Association team may practice more than 20 hours per week. This includes chalk-time, film review, meetings, etc. If a school is in violation of this rule it can be fined and reprimanded according to region policy.

## **REGION PASSES 10**

Each member school will receive ten (10) region passes to utilize at their discretion. Region passes will be accepted at all region 15 events. Region 15 passes will not be accepted for state events hosted at schools. Any abuse of the region pass will be subject to sanctions by the region 14 board of managers.

## **POSSIBLE GAME CANCELLATIONS**

In the event that an epidemic should come about at a school and/or community that would hinder a team from playing a scheduled game, the following will take place: the two principals, along with the local health department, a district administrator, and another administrator from another region school will get together and a decision will be made as to whether the game should be cancelled and how the make up will proceed. All schools have committed to be wise and prudent and respect the situation of other schools.

### ***1. Admission Fees and Tickets for Region Events***

- A. Adults (18-64) - \$7.00
- B. Students from the hosting school - Free
- C. Students K-8 - \$4.00
- D. Guest students with school ID - \$4.00
- E. Senior Citizens - \$4.00
- F. Student Body Officers, Cheerleaders and drill team in uniform - Free
- G. Volleyball and basketball games will be charged at all levels.

### ***2. Supervision of Region Activities, Tournaments and Meets***

- A. Any school hosting a Region 15 tournament or dual competition activity is responsible for providing adequate administrative supervision for the activity.
- B. It is the responsibility of the chairman of each individual activity to see that Region 15 tournaments and meets are planned and well organized. It is the responsibility of the host school to provide adequate general supervision for the activity. If the host school is not the school of the chairman, there should be a clear understanding between the activity chairman and the host principal regarding the activity. In any case, the host school must provide general supervision for activities taking place in that school. Provide police and administrative supervision at the events and in the parking lots and possible trouble spots as identified by the local school plan.
- C. School administrators who are present at games agree to take immediate, definitive action towards disruptive or unsportsmanlike students or fans.
- D. No sitting on the front row or standing on the floor in basketball.
- E. The host school will clearly define seating areas for both home and visiting students. These areas should accommodate pep clubs as well as the general student body.
- F. If problems of a violent nature occur at any region site as a result of a school's failure to follow these recommended procedures or to provide proper supervision, the Region 15 representatives will take restrictive action against the offending school.

### **3. Accommodations for Visiting Teams**

- A. Dressing rooms should be appropriately prepared for visiting teams with a clean area, lockers, showers, and whiteboards. Towels will not be furnished to visiting teams by the host school.
- B. Visiting teams must bring their own towels if they desire to use them. All dressing room facilities must be left clean and orderly. The visiting head coach will check facilities prior prior to departure.
- C. If a head coach receives a key to dressing room facilities from the home school, the key should be returned to the home school's head coach or designee. **LOCKER ROOMS SHOULD BE SECURED AND LOCKED AT ALL TIMES.**

### **4. Rules for Region 15 Tournaments**

All Region 15 tournaments will follow the same rules as UHSAA state rules. All expenses must be pre-approved by the Region 15 financial representative for payment.

### **5. Officials**

Host Schools should provide for someone to meet officials and show them to their dressing rooms both before and after any event (and during halftime). Any misconduct of officials, including failure to show or tardiness is to be reported to the Arbiter in charge of the involved activity. A detailed report including names and improper

conduct

shall be submitted in writing to Region 15, the UHSAA office, and the arbiter involved.

### **6. Policies Relating to Student Behavior at Region 15 Activities**

- A. Bands & Drums:
  - (1) A pep band may be provided by the host school only. During basketball games, pep bands are to play during regulation time-outs, quarters and half-times only. An advisor must always be present if a band is to perform.

(2) Drums are to be used only to play with the band, as part of an organized cheer, and to be part of the pep club's marching activities. Drums and any other instruments are not to be used indiscriminately as noisemakers or for drum rolls or instrumental fanfare after each basket.

B. Students Body Officers:

Student Body Officers are expected to demonstrate good sportsmanship and to welcome visiting officers to their school. Students Officers should be easily identifiable (sweaters, shirts, etc.) and available to help make interscholastic activities safe and successful.

C. Cheerleaders:

(1) Cheerleaders of the host school should initiate a meeting with the guest cheerleaders immediately before the game. The two groups should work cooperatively together during the game. At basketball games, cheerleaders will occupy the space behind the basket closest to their student body. Cheers or songs which are derogatory or insulting are not to be used. Cheers must be under the direction of official school cheerleaders and song leaders.

(2) All stunts and pyramids must be in accordance with risk management policies.

(3) No children are to be used in cheerleading or pep club activities. Separate half-time activities are to be approved by the principal or athletic director.

(4) Cheerleaders should encourage good sportsmanship at all times. Each student body is to exhibit good sportsmanship. The administration and advisors are, in the interest of proper education, to stress positive sportsmanship and do all in their power to eliminate booing, catcalls, or unsportsmanlike behavior. No cheering is to be derogatory or obscene.

(5) Cheerleaders and/or mascots are to refrain from conducting cheers or stunts during free throws.

(6) Megaphones may be used by cheerleaders at football games, and only for communicating with the cheering section. Megaphones may not be used at basketball games. "Refer to the UHSAA Handbook for other activities"

(7) No electronic cheering methods will be allowed.

(8) A supervisor must be present when cheerleaders perform.

(9) The cheerleading and team members must attend the Utah School Board's Risk Management Clinic in the spring.

D. Pre-game, Half-time, and Post-Game Activities:

(1) The starting line-up may be introduced prior to the activity. A well-planned flag ceremony may be presented.

(2) All activities should come to a halt immediately when the flag ceremony begins. Headgear should be removed. Activity should remain suspended until flag ceremony is over. Starting line-ups may be introduced following the flag ceremony. All pre-game activities must be concluded before the official time of the event.

(3) The announcer should call everyone to attention as the flag enters. The announcer should be objective and impartial announcing a game.

(4) Football half-time: Half-time entertainment has ten minutes which includes time to get on and off the field. Exceptions can be made by mutual agreement for special occasions.

(5) Basketball half-time: Maximum of eight minutes for half-time entertainment which includes time to get on and off the floor. Exceptions can be made by mutual agreement for special occasions.

(6) The host school pep club or drill team may use pom-poms if the floor is swept after each use, or at the earliest convenient time.

(7) A supervisor must be present when student groups perform.

(8) Coaches are responsible for the conduct of their athletes. No activity will be conducted to belittle or humiliate opponents, including organized post-game demonstrations on the floor, field or in the stands.

A. Visiting teams will leave the field or floor immediately after the game ends.

B. Visiting teams (basketball) will leave the team locker room within 20 minutes after the game ends.

(9) No gum, sunflower seeds, or sugar drinks will be allowed on turf fields.

(10) Any senior recognition at end of season cannot delay start of game.

(11) There should be no post game demonstrations by either team on the floor/field at the end of the game until the visiting team has left the floor/field. Any and all activities must have the approval of the school administration.

E. Spectator Conduct/Sportsmanship:

(1) Encourage student groups to initiate sportsmanlike activities during the season.

(2) Other than authorized spirit groups (cheerleaders, pep club, drill team), no spectators will be allowed on the field or floor during game time, between quarters, half-time or post game. (Until visiting team exits the floor/field).

(3) The throwing of any objects, including confetti, torn paper scraps, crepe paper, toilet tissue, etc., is not allowed.

(4) Visiting schools are not to conduct any type of post-game activities.

(5) The use of negative or insulting chants is not to be used.

(6) For reasons of student safety and I.D. purposes, student will not be allowed to have any body paint on any area of the body except on the face. All other body painting is prohibited. The school administration is responsible to enforce this rule.

(7) All laser pens are prohibited.

(8) "Region 15 Spectator Support Items" – Refer to the UHSAA Handbook pg 55 (under Information – Spectator Support Items).

Banners and Signs:

(9) No negative banners or posters of any nature will be displayed in the area of competition. A sign welcoming the visiting team is encouraged.

(10) A sign of a positive nature on the football field at half-time for the home teams to run through will be allowed.

(11) All banners will be used by the Cheerleaders only.

(12) No spectator banners or signs, with the only exception being banners used to honor seniors on senior night.

## **7. UHSAA Sportsmanship Policy**

A. Sportsmanship Conduct:

(1) INTRODUCTION – The effective Utah secondary school should support both an academic program and an activities program. The programs should do more than

merely coexist, they should be integrated and support each other in “different” arenas. The concept of “sportsmanship” should be taught, modeled, expected, and reinforced in the classroom and in all competitive activities.

(2) PHILOSOPHY – Activities are an important aspect of the total education process in Utah schools. They provide an arena for participants to grow, to excel, to understand and to value the concepts of SPORTSMANSHIP and teamwork. They are an opportunity for coaches and school staff to teach and model SPORTSMANSHIP, to build school pride, and to increase student/community involvement; which ultimately translates into improved academic performance. Activities are also an opportunity for the community to demonstrate its support for the participants and the school, and to model the concepts of SPORTSMANSHIP for our youth as respected representatives of society. SPORTSMANSHIP is good citizenship in action!

(3) *REGION XV SPORTSMANSHIP CODE OF CONDUCT*

(This statement should be read prior to every Region event where there is a public address system available)

***“Ladies and gentlemen, welcome to (home high school) for tonight’s/today’s athletic contest. We welcome our guests from (Visiting High School) and wish all players good luck in tonight’s/today’s game. Both schools are members of the Utah High School Activities Association and support the new statewide sportsmanship program Raise- the-Bar. Sportsmanship does matter and we ask for your support in demonstrating respect for the game and all the participants by refraining from negative cheers, chants or behavior. Do Rowdy Right”***

\*UHSA policies will be followed for all events as listed below, unless otherwise noted in Region Manual.

***STUDENT AND SPECTATOR SPORT ITEMS***

In the chart below, ONLY those items marked “Yes” will be allowed as fan/spectator support items at all Region 15 Contests. It is recommended that schools follow these regulations during regular season and region tournament play. Sportsmanlike vocal cheering and support from team bench area are encouraged. The items indicated on this page are for use by all spectators.

B. General Sportsmanship Guidelines

SPORTSMANSHIP is a way of thinking and behaving. The following sportsmanship policy items are listed below for clarification:

- (1) Be courteous to all (participants, coaches, officials, staff, and fans).
- (2) Know the rules. Abide by and respect officials’ decisions.
- (3) Win with character and lose with dignity.
- (4) Display appreciation for good performance regardless of the team.
- (5) Exercise self-control and reflect positively upon yourself, the team, and the school.
- (6) Permit only positive sportsmanlike behavior to reflect on your school or its activities.
- (7) If flagrant violence occurs in any event in which a Region 15 school is participating, the Region will review the incident upon request and on a case by case basis to determine possible consequences to participants(s) that are involved. These consequences may result in, but not be limited to, suspension from events(s),

suspension for the entire season, and/or may include other consequences as determined by the Region.

- C. Unsportsmanlike Ejections and Fighting Policy – Appeals Process  
(1) See the Utah High School Activities Association HANDBOOK.

### **8. Events Schedules**

(1) All Region 15 regularly scheduled events constitute a contract between schools. The failure of a team to participate in a scheduled contest without prior mutual consent at varsity levels may result in a fine up to \$500 and forfeit assessed by the Board of Managers, plus the cost of any officials etc. to the affected schools.

(2) Both AD's are to agree to the change before the game or match. If both schools agree on a change of time and date of an activity, the host school must notify the of the change in time for him/her to notify the officials. All officials (Varsity, J.V., Sophomore, and Freshman) will be arbitrated by UHSAA. Call changes to UHSAA offices. All costs associated with changing the time and date will be incurred by the school requesting the change.

(3) All invitational meets, matches, or tournaments must be approved by the UHSAA thirty days prior to the activity. Appropriate fines will be assessed against a host school and others who participate in unsanctioned events.

### **9. Miscellaneous**

(1) Awards are to be given according to the published Region 15 format. This includes but not limited to All-Region, and Academic All-Region. No additional awards will be allowed unless pre-approved by the Region.

### **10. Game starting times and participant regulations**

No sports activity may begin before 3:30 p.m., unless approved by the Board of Managers. However, varsity football may not start before 4:00 p.m. until Day Light Savings. Thereafter, games may start at 3:30 p.m.

### **11. Tie-Breaker Rule**

A. Ties in win-loss records between teams for first place will result in Region Co-Champions being declared and duplicate trophies will be awarded.

B. In the case of a tie for first, second, third, etc. in region play, the following procedure will be followed (If the tie does not include a team that will be eliminated from the playoffs):

1. Overall Region Record.
2. Head-to-Head results.
3. Point differential, (not scored) in head-to-head games.
4. Results (W or L) against other region teams starting at the top of region and working down (for example, if two teams tie for first, then compare results against the third place team on down. If two teams tie for third, compare results against the first place team and then second, if necessary, and on down. If one team has better results against a higher team, that team would get the higher place).
5. Number of points allowed in all REGION games.

6. Flip of coin.

C. Two way tie for the last/final playoff spot.

1. Overall Region Record
2. Head-to-Head results (if teams split games, go onto step 3)
3. Play-in game at a neutral site.

D. In cases where tournament berths are at stake for three teams involving two places, the following will apply: If a single team can be identified as a clear-cut winner in games between the schools involved, that team will receive the highest seed and the other two teams will play for the remaining berth. If no-clear cut winner can be determined, a coin flip will determine the lowest seed (odd coin) and the losers of the coin flip will play off for the higher seed.

## **12. Moratorium**

A fine to be determined by the Board of Managers, which is paid by the coach, may be assessed to the coach of any team that is in violation of the designated days for moratorium of practice and play. This is in addition to the UHSAA sanctions. Please see the UHSAA Handbook for specific moratorium dates.

## **13. Fine for violations**

A fine may be assessed for a violation of region rules as determined by the Region 15 Board of Managers.

## **14. Eligibility**

Eligibility rules for Region 15 will be determined by the Utah High School Activities Association By-Laws:

To participate in any UHSAA Region VIII or state interscholastic competition, an individual must be a full-time student in the school he/she has established eligibility. No student shall be eligible to represent his/her school if he/she is failing more than one subject or has a GPA of less than 2.0. Where a student has failed to meet the minimum requirements set forth above, he/she shall also be ineligible for participation in UHSAA or Region VIII activities in the succeeding grading period. Incompletes are computed as F's for eligibility.

A. No student who is ineligible for a grading period should represent the school in any pre-season or practice contests with varsity, junior varsity, sophomore, or freshman teams.

1. The word represent shall be defined below. Any violator of the Scholastic Eligibility By-laws shall not:

- a. be in uniform on competition night;
- b. warm-up with the team;
- c. sit on the bench with the team;
- d. be listed on the program roster;
- e. be introduced as a member of the team.



The above student/participant may, however, continue to practice with his/her team upon approval of the school administration.

- B. The date report card documents are posted officially by the school becomes the date which the scholastic rule is applied.
- C. An incomplete is considered a failure until it is made up.
- D. A student enters upon high school work when he/she enters the 9th grade regardless of whether the 9th grade is in the high school or a separate junior high school. This means that all 9th or 10th grade students must not have failed more than one class the previous grading period and have a GPA 2.0 or higher.
- E. To establish academic eligibility for 1<sup>st</sup> term of a new school year, 4<sup>th</sup> term grade deficiencies must be made up in the same subject area by attending summer school, night school or by any other method acceptable to and by the deadline prior to the 1<sup>st</sup> term of the preceding year and shown on the student's transcript.

## **16. Coaches**

- A. Coaching behavior on the bench is reflected in student behavior. It is the responsibility of the Athletic Director to direct the coaching staff to be examples of good sportsmanship at all times.
- B. Coaches are not to exert undue influence on officials before, during or after any contest. Any complaints or protests are to be made through school administration.

## **17. Number of Games**

Teams which exceed the number of games allowed in any season may forfeit from their region schedule the number of games exceeding the limit. Forfeited game(s) may be subtracted from the region win/loss record of the offending school. For each extra game, one win may be subtracted from record and one loss may be added. Other sanctions may be taken by the Region 15 Board of Managers.

## **18. Duties of Region Chairpersons**

- A. Conduct all meetings pertinent to respective activity.
- B. Coordinate and manage all Region 15 competitions and tournaments of respective activity.
- C. Select and honor respective All-Region 15 teams where applicable.
- D. Be direct liaison to Region 15 Board of Managers.
- E. The all Region 15 teams should be selected by the coaches within two weeks of the conclusion of the activity where applicable.

## **19. Undue influence rule, violation**

A. If there is clear evidence that a coach has violated Article 1, Section 9 of the UHSAA bylaws or interpretations he/she will appear before the Region 15 Board of Managers and may be under the direction of the UHSAA to receive any or all of the following for the first violation:

- (1) A letter of reprimand.
- (2) Suspension
- (3) Fine

- B. If it is determined a coach has violated the undue influence rule a second time, the coach may be suspended a minimum of three contests or one-half of the remaining Region 15 schedule (whichever is greater).
- C. A third violation may mean suspension for the remainder of the current season.

- . 1) The first official day for games to be played on the approved UHSAA calendar date (see UHSAA handbook and calendar).
- . 2) Each team (Varsity & JV) will be allowed to play 25 games as per UHSAA rule.
- . 3) All Region Varsity and J.V. Games played on the same day will begin at 3:30 p.m.
- . 4) Each team will be allowed 15 minutes of warm-up and infield practice. All teams should stretch closest to their foul line. No circling up in center field.
- . 5) All league games (Varsity & JV) will be played on the date and time scheduled, depending upon weather and field conditions.
- . JV games will only be on Tuesday Wednesday of the week. If a team is traveling to non-region tournament during region play and needs to reschedule a game(s), then it is the responsibility of both coaches to mutually agree on the dates for the rescheduled date, to be played before the next regularly scheduled region game, and then report that to the region chairman. The scheduling for this must be done before the beginning of the regular region season.
- . Each postponed game must be made up in the order of the postponement. A postponed game will be made up on the first available date, including Saturday. During the first round of region play, a postponed game will be made up by “flip flopping” the schedule and playing at the visiting team’s field, if that field is playable and if district bus transportation is available. The visiting team will reverse the schedule for that game during the second round. In the event of bad weather, it will be the responsibility of the home team coach to notify the visiting school and the officials. This should take place by 12:00 p.m. It is the responsibility of both coaches to communicate with each other in the process of rescheduling games for the next available date.
- . 6) Any game(s) not made up on the next available date will result in a forfeit for one or both teams, depending on the offending team(s). The Region Board of Managers and both coaches will be consulted to determine the offending team. No team will be made to play five (5) games in a week, unless they choose to do so.
- . 7) When a game is “called” because of darkness or weather, etc., in the first round, the game

will be resumed as the preliminary scheduled game of the two teams in the second round, followed by the completion of the second round game. JV games that have to be bumped will be resumed on the next available date. The home field coach will be responsible for notifying all those involved: coaches, umpires, and principals.

8) The recommendation of the UHSAA on number of innings pitched per week will be followed (Currently 14 innings.)

9) A region trophy to the first placed team(s) in regular region play. No medals. Seeding for the state tournament will be based on how the league finishes in that order. In case of a tie for seeding purposes, region tiebreaker rules will be in effect.

10) An all-region team will be selected on the last Saturday before the state play-offs begin to be determined by the region baseball chairman. Coaches present will be allowed to select players for all-region teams.

11) Please refer to “General Policies” in the Region 15 Handbook for all other Region 15 rules and the UHSAA handbook or website for all UHSAA rules.

12) An all-region team will be selected in the following format:

a. 1st place will select 5 players

b. 2nd place will select 4 players

c. 3rd place will select 3 players

d. 4th place will select 2 players

e. the remaining teams select 1 player

14) Second team all-region reduce is all-region totals by 1.

13) Academic All-region is any senior with a cumulative GPA of 3.75 or higher

1) Games will be played on the same day at the following times:

- . 2) Halftime for basketball will last ten (10) minutes. Halftime activities must be kept to seven (7) minutes. Minor variations can be made with mutual consent of schools involved.
- . 3) Wilson is the designated ball for both Boys and Girls State Tournaments. Use of this ball is recommended for Region 15 games.
- . 4) Pre-season game times and dates are site-based decisions.
- . 5) In the event of a tie, the Region 15 tie breaker rule applies.
- . 6) Teams may film their own games; however, no filming of opponents is allowed at any level.
- . 7) Each school is responsible for providing a dressing room and private discussion area for officials.
- . 8) The start times and dates can be changed only by mutual consent of both teams involved and approval by the Region 15 Board of Managers. If a game time or date is changed, it is the responsibility of the home to notify the arbiter.
- . 9) Selection of All-Region Teams takes place in a meeting of coaches under the direction of the Region Chairperson. An open format, to be decided by the coaches, determines the method of selection. All-Region Academic Certificates are award to senior athletes with a cumulative 3.75 GPA. Coaches shall provide names to the Region Chairperson at the All-Region selection meeting.
- . 10) A Region 15 trophy will be awarded to the first-place team based on winning percentage. Teams tied for first with the same winning percentage will be named co-champions and will share the title and be seeded in the tournament based on the Region tie breaker procedure. Each co-champion team will receive a first place trophy.
- . 11) A representative of Region 15 basketball coaches will keep an up-to-date record of region standings.
- . 12) General courtesies are recommended for games and are as follows:
  - a. Each school shall provide the visiting team with a secure, clean locker room, a writing board, and an area for private discussion during halftime. Accessibility to a taping table is encouraged.
  - b. If pre-game activities are expected to run longer or they are different than normal, a

schedule of the events (including the flag ceremony and introduction of players) shall be provided to coaches and referees.

- c. **5 Minute Courtesy Rule:** At the conclusion of each game, there is to be 5 minutes put on the time clock between games to have the team playing in the previous game clear the bench, allow teams to exit, the floor to be swept, etc. During this 5 minutes there is to be NO ONE on the floor.
- d. Senior Night festivities will be held prior to the Varsity game.

13) All region team will be selected by the region coaches.

- . 2) Halftime for basketball will last ten (10) minutes. Halftime activities must be kept to seven (7) minutes. Minor variations can be made with mutual consent of schools involved.
- . 3) Wilson is the designated ball for Boys' and Girls' State Tournaments. Use of this ball is recommended for Region 15 games.
- . 4) Pre-season game times and dates are site-based decisions.
- . 5) In the event of a tie, the Region 15 tie breaking rule applies.
- . 6) Immediately after the contest, both teams will shake hands and the visiting team will exit the school within 30 minutes of the game end.
- . 7) Each school is responsible for providing a dressing room and private discussion area for officials.
- . 8) The start times and dates can be changed only by mutual consent of both teams involved and approval by the Region 15 Board of Managers. If a game time or date is changed, it is the responsibility of the home team to notify the arbiter.
- . 9) Selection of All-Region Teams takes place in a meeting of coaches under the direction of the Region Chairperson. An open format, to be decided by the coaches, determines the method of selection. All-Region academic certificates are awarded to senior athletes with a cumulative 3.75 GPA. - . 13) All schools are required to use adults on the clock and scoreboard. (Varsity Only).

- . 15) General courtesies recommended for games and are as follows:

Activity Chair: First Competition Date:

- . 1) Cross country meets will begin at 3:30 p.m.
  - . 2) The host school will designate a well-marked course. Distances for region meet courses will range from 3,000 to 6,000 meters.
  - . 3) Qualification for State finishers will qualify with UHSAA yearbook.
  - . 4) The winner of the region trophy will be determined by the team scores at the Region Meet.
  - . 5) Medals will be awarded to the top 10 finishers in the Region Meet in both the boys and girls varsity division. Medals will be awarded to the first 10 finishers in the boys and girls Junior Varsity division. Additional medals may be awarded by the coaches, as well as certificates for academic all-region team members.
  - . 6) Coaches may run only 7 runners in the “Varsity” Region Championship.
  - . 7) Two paid Officials will be arranged to start, score, and referee the Region Meet. Each school will provide one adult volunteer for the Region Meet.
  - . 8) At region meets, girls will run first, then boys, unless agreed upon ahead of time by all coaches involved.
  - . 9) Please refer to “General Policies” in the **Region 15** Handbook for all other **Region 15** rules, and the UHSAA Handbook for all UHSAA rules.

3. Drill teams compete in the same three (3) categories head to head at region and state competitions. The UHSAA has esignated MILITARY, DANCE and KICK as the three (3) official categories for competition in the upcoming 2018-19 school year.
4. Drill team coaches must attend a mandatory meeting prior to the Region 15 drill team competition. Each coach will draw a number for her team, which will determine each team's performance order for each category. The order of events for the Region 15 Tournament will be Military, Dance and Character routines.
5. All coaches must submit the following information for the region program no later than Please submit information electronically, compiled by Competitive Director:

A team picture (high quality with sharp contrast)

Names of drill team members and officers

Names of school administration and athletic director

All-Region team names of three (3) deserving drill team members, either seniors or second year members

Academic All-Region (team members with a 3.75 cumulative grade point average or higher) Drill teams have fifteen (15) minutes of floor time on the day (sound check with or without team) of the competition at the host school and one (1) hour practice session prior to the competition scheduled by the Region 13 Representative at the competition site.

6. The following awards will be presented at the Region 15 drill competition.

Plaques will be awarded to 1<sup>st</sup> thru 3<sup>rd</sup> place winners in each category

All events will count toward the region trophies. There will be no Interps at region unless they become state events. There will be one region trophy awarded at the Region Debate Tournament.

**Speech/Forensic Events:** Oratory, Impromptu, National Extemp., Foreign Extemp., **Debate Events:** Policy, Lincoln Douglas, Public Forum, Congress.

Double Entry of competitors is allowed, as long as they only participate in one event per day. Double

entry is not allowed for students competing in policy debate. Events held on Friday will be Oratory, Impromptu, Foreign Extemp., and National Extemp. Events held on Saturday will be Policy, Lincoln Douglas, Public Forum, and Congress.

In line with the procedure of the National Forensic League, a student who is double-entered and qualifies outright in both events, will forfeit the slot he or she will not fill at State to the next contestant in line, providing that contestant has a winning record (50% or better). On the Region Tournament registration form, double-entered students will be required to declare the event in which they would like to advance at State and the event in which they will forfeit their slot, should they qualify in both events.

#### Judges Requirements:

- a. Schools must bring one qualified judge per two policy debate entries, one qualified judge per every four Public Forum, and Lincoln Douglas debate teams or portions thereof, one qualified judge per five IE entries, and one Congress judge for any Congress entries. Schools that do not fulfill their judging requirement will have entries dropped from competition.
- b. The qualified judges for Congress rounds will be confirmed by coaches at the Region Pairing meeting.

Region Meet Pairings: a. All schools competing at region have to attend the Pairings Meeting for Region. All schools must send a coach or a

coach designee to pairings. They will not be allowed to participate in the region meet if not represented. Region

Pairing Meeting will be held @ TBA. Debate Pairings:

- a. The intent is to have each school meet every school in the Region, if that can't happen, the pairings will be made within reason.
- b. Individual teams must not meet the same team more than once.
- c. Recommended: 3-4 rounds in policy, 4-5 in LD and Public Forum.

#### Individual Event Pairings:

- a. Random selecting shall be done in each event.
- b. 3-4 rounds of competition will take place.
- c. Where possible schools should not compete against members of their own school's team.
- d. Congress Pairings:

Congress sessions will last 5 hours total. Legislation will be selected from the UDCA the docket which will be published to all schools. The tournament will use the UDCA Orders of the Day.

- . 6) Medals: Each medal will say the event name and “Superior” and will be given to the top six finishers in each event. The following number of medals will be needed: Public Forum – 10 medals; LD – 5 medals; Policy – 10 medals; National Extemp. – 5 medals; Foreign Extemp. – 5 medals; Oratory – 5 medals; Impromptu – 5 medals; Congress – 5 medals. 10 blank Superior medals in case of ties.
- . 7) General Guidelines:
  - a. In forensics and debate competition, each individual is limited to ten meets per year, excluding region, state and national competitions.
  - b. Region will pay for judges at the Region Meet; \$35 for each judge who judges for Friday, and \$50 for each judge who judges for Saturday (as per new UHSAA guidelines).
  - c. March/April LD topic and March PF topic will be used for the Region Meet.
  - d. In the event a student misses a round, his/her points will still count toward sweepstakes.
  - e. Please refer to “General Policies” in the Region VI Handbook for all other Region VI Rules, and the UHSAA Handbook for all UHSAA Rules.
  - f. Sweepstakes points will be calculated as follows:
    1. The top 1/4 of contestants will be given superior (5 points).
    2. The next 1/4 of contestants will be given excellent (3 points).

6. Region Championship Meet will precede the state meet by at least ten (10) days.
7. Academic All Region nominees (seniors only, 3.75 Overall G.P.A. or higher) must be submitted along with the region entries.

## REGION DUAL MATCH PLAY:

- . 1) All Region Dual Matches will be played on the date scheduled; of course, this will depend upon weather and court conditions. Host coach will be responsible for contacting visiting coach by 1:30 p.m. if conditions are insufferable.
- . 2) All region dual matches will begin at 3:30 p.m.; however, coaches may agree to begin at a later time depending upon the circumstances.
- . 3) Each team is expected to have a Junior Varsity contingent. A school's Junior Varsity contingent will travel with the school's varsity team to the host school and play their matches on the day of the scheduled varsity matches. The coach of the visiting team will call the host coach in advance and ascertain the number of Junior Varsity matches to be played. Junior Varsity players will play at least a pro-set.
- . 4) Varsity matches will consist of 2 out of 3 sets, 12-point tie-breaker, regular scoring.
- . 5) Both coaches at a dual match will provide a written line-up of players by positions to the opposing coach.
- . 6) Players are limited to ten-minute warm-up; the warm-up does include practice serves.
- . 7) A player who is slated to play, but who arrives late; i.e., during the ten-minute warm-up, may be inserted into his position; however, the player will not receive the allotted ten minutes to warm up. The tardy player will receive the balance of the team minutes to warm up. Tardy players will be penalized according to the rules beginning at 3:30 p.m. at dual meets. The only exception is if both coaches agree to a later time after being made aware of extenuating circumstances. This exception applies at Region if other players can be assigned to available courts for that round. If a player arrives after the match he was slated to play has begun, the tardy player will default the match.
- . 8) The home team will furnish 3 balls for each varsity match; a three set match will receive three new balls at the beginning or the third set.
- . 9) A coach may move a singles player to doubles and vice-versa; however, the players must be ranked according to ability in both singles and doubles.
- . 10) Coaching on change overs can only be part of the 90 seconds slowed. ### **REGION TOURNAMENT PLAY:**

1) To qualify for the Region Tournament at a particular position, a player must have played at least five varsity dual region matches. If extenuating circumstances preclude this from happening, then a majority of the coaches would have to agree on any exceptions at the pre-region tournament seeding meeting.

2) Seeding of the Region Tournament will be conducted by the region head coaches prior to the Region Tournament. Seeds will be based on Region dual matches results at a particular position. The most recent rankings by the Utah Tennis Association may be used as a secondary source for seeding. Matches start at 1:00pm. the first day and the last day will start at 8:00 am. Must have a minimum of two referees/U.T.A. 268-0505.

3) Players who have played at the #1 or #2 singles position three or more times during region dual matches are not eligible to play at the #2 doubles position at Region Tournament.

4) J.V. Tournament: Schools can enter 3 singles and 2 doubles. All matches, except the finals, will be 8 game pro set 8 games with 12-point tie-breaker at 8 all. Championship matches will be 2 out of 3 sets with regular scoring.

5) The first round of the Regional Tournament will be **a single elimination round.**

6) Stacking is not permissible and could result in UHSAA sanctions. In an effort to promote fair play and wholesome team competition thereby fostering a healthy educational environment, the Utah High School Activities Association offers the following guidelines in regards to stacking:

A. Legitimate and ethical “placing of players”. Any lineup which places a better skilled player above a lesser skilled player or a better skilled doubles team above a lesser skilled doubles team is legal.

B. Legitimate lineups according to skill ability: Skill ability shall be defined as the number one singles player shall be better than the number two singles player who shall be better than the number three singles player. The number one doubles team shall be better than the number two doubles team.

Coaches should enter players at the positions which their skill dictates. Juggling or shuffling the positions to gain an advantage is unsportsmanlike and creates an unhealthy educational environment. . 8) No more than fourteen (14) matches will be played by team players during the course of the UHSAA tennis season. This restriction does not apply to those matches played either at the Region, Divisional, or State Tournaments. To qualify for state a player must have played 5 of those Varsity matches at the particular position.

9) All Players in Region Tournament shall wear a team uniform shirt.

**JUNIOR VARSITY REGION TOURNAMENT PLAY:**

# TRACK & FIELD GUIDELINES

Region Chairman: Juan Diego and American Leadership Laura Nichols:

- 1) Track meets for boys and girls are to be conducted concurrently.
- 2) Track meets will start at 3:30 p.m. on Wednesdays or Thursdays
- 3) The following awards should be given. A. 1 Team Region Trophy (Boys & Girls). B. Region J.V. Meet: Certificates for the first six (6) places in individual events and first in the relays. C. Region Championship Meet: Medals for the first six (6) places in individual events, and medals to the first three (3) places in relay events. Top four (4) places at Region Championship qualify for the State meet. (Students can also qualify for the state meet at invitational meets.)
- 4) The responsibility of deciding if a meet should be cancelled rests with the host school. Although input from the other participating schools should be obtained whenever possible, the final decision rests with the host school. The host school will phone the other participating schools and cancel the meet by 1:00 p.m.

Anyone qualifying for a state event cannot participate in the J.V. Region Meet. **Home** school is appointed Meet Director in charge.

Visiting schools will be responsible for staffing and running two (2) Field Events during the Meet.

- H. Host school must hire a field judge from the UHSAA who is US Track & Field certified (Covered by Region)
- I. Each school will be responsible for staffing and running one (1) Field Event for Region Championship and the J.V. Championship Meet.
- J. If the meet is postponed due to weather, the first event would not begin before 4:30 p.m.
- K. Region meet schedule will match event schedule for State Meet.
- L. To Qualify for Region Meet an athlete must compete in that specific event at at least 1 Region Meet.
- M. Region Meet will follow the State Meet schedule. Exhibition events 4x800 and 4x200
- N. Region Meet will utilize NFHS 5 team scoring
- O. Region Meet - 1 false start equals disqualification.

. 8) Budgets:

# WRESTLING GUIDELINES

All scales used in an official weigh-in will be certified annually before 1<sup>st</sup> region dual. Each school is responsible to notify the Utah Department of Weights and Measures. Scales must be certified prior to the beginning of the competition. The home school is responsible to provide a certified scale for weigh-in at all Region Duals.

Starting times for Region 15 Weigh-ins - 4:00 pm

JV matches - 5:00 pm Varsity matches – 6:00 pm or following J.V.

Tri meet start times- JV/Varsity run concurrent on two mats Weigh-ins- 3:00 pm First Match- 4:00 pm Second Match- 5:30 pm

Third Match- 7:00 pm

**2) REGION VARSITY TOURNAMENT-** While it is not always possible for teams to fill every weight class during the dual team wrestling tournament series, it is expected teams will not forfeit an excessive number of weight classes, when they have wrestlers capable of wrestling at those weight classes.

1. Each school may enter two wrestlers per weight division.
2. Wrestlers will be seeded into the tournament by criteria; attempts will be made to seed six.
3. All rounds will be scored in the tournament.
4. Weigh-ins will be conducted as per state guidelines.
5. The seeding meeting will be under the direction of the host school with the Region Chair doing the pre-seeding. Byes will be randomly assigned to an open position for each weight.
6. After each Region dual, the home coach will be required to fax or e-mail the results of the Region 15 dual to the region chair for seeding purposes before their next home dual.
7. Each coach will be required to bring to the Region 15 seeding meeting their team's alpha-master list, eligibility list, wrestlers' names, weight, grade, and overall varsity record. This list should include all Region duals highlighted with the weight in which the wrestler competed.
8. Wrestlers may not change weight class after the seeding meeting without a coach's vote.
9. Double bonus points will be awarded to wrestlers who received byes and then win their subsequent match in the championship round only. Advancement points will be awarded to winners in the championship or consolation brackets with previous round byes.
10. Region Tournament Admission, Fees, and Ticketing will be followed.

- All gate money belongs to the region.
  - The host school will keep all concession money.
  - The region will pay tournament expenses.
  - The hospitality room for coaches and officials will be subsidized by the Region 15 \$200.00.
- COMMUNICABLE SKIN CONDITIONS AND SKIN CHECKS

- At the Region Dual Team Tournament, the officials will conduct the skin checks at weigh-ins.
- Any wrestlers with suspect skin conditions MUST present a current, completed Wrestling SkinCondition Report at the time of weigh ins signed by a medical professional stating the condition is NOTcommunicable OR stating the wrestler had a communicable condition that is no longer communicableas of the date of the meet.
- If a designated onsite medical professional (Medical Doctor, Doctor of Osteopathic Medicine, Doctor of Chiropractic, Physician’s Assistant, or Advanced Registered Nurse Practitioner) is present atthe weigh ins he or she has the authority to rule on any suspect communicable skin conditions.
- This medical professional has final authority to allow, or deny, participation regardless of what isindicated on the UHSAA Skin Condition Report Form presented by the coach.

12. A Hospitality Room is available during the tournament for coaches and officials.

13. ALL matches in the state dual team tournament series will be (3) two minute periods (222), plus overtime, if needed.

14. Locker rooms will be available for wrestlers. ALL wrestlers should plan to shower when they arefinished wrestling for the day. This will help alleviate any concerns about wrestlers becoming ill ordeveloping a communicable skin condition from not showering. Soap & towels are NOT provided.

15. Seating for team personnel will be provided on the floor at Murray High school while their team iscompeting. When they are not competing all team personnel will be directed to a seating area in thebleachers.

16. A Dual Meet Championship Award will be awarded.

17. Tournament times will be set by host school.

18. The following criteria will be used for seeding wrestlers in Region 15 Wrestling Tournament:

- a. Agreement among coaches who is the best wrestler (4-2 vote).
- b. Region wins at the same weight.
- c. Head-to-Head record in any competition.
- d. Previous State finish in order of finish (same weight).
- e. Common opponents

- f. Region wins.
- g. Previous State finish in order of finish (same weight)
- h. Coin Flip

19. Winning coaches of each region dual must send results to the region coaches by the following Monday after a dual match. Every two weeks the region chair will e-mail the results/region standings to the other region coaches.

20. Please refer to “General Policies” in the **Region 15** Handbook for all other **Region 15** rules, and the UHSAA Handbook for all UHSAA rules.

#### 21. STARTING WEIGHT CLASS

- As per NFHS rules, the starting weight class will be drawn immediately before weigh ins at regional and duals. Each round will begin one weight class beyond the previous round.
- A pre-dual disk toss will determine which teams’ wrestlers have the choice of position at the start of the second period and which teams’ wrestlers are to report to the scorer’s table first for each weight class.

#### TEAM TIES AT REGIONAL DUAL TEAM COMPETITION

In the event a tie score exists in a dual meet at the regional or state dual team tournament, the criteria found in the NFHS Wrestling Rule Book will be used to break the tie.

- Officials will conduct Weigh ins and will take place at Murray High School on Saturday January 14, 2017 beginning at 7:00 am.
- All schools must present the proper Track Wrestling weigh in forms at the time of weigh in, listing the wrestlers eligible to compete at the Regional and Dual Team Wrestling Tournament.
- Meet management will keep the original forms and make copies for coaches and table workers.
- The only scale allowance given for regional dual is the 2pound growth allowance. 108, 115, 122, 128, 134, ...
- Platform scales must be certified (by a government agency) by November.

## **MUSIC**

### **ADJUDICATION**

1. Adjudicators for the Festival will be selected from the approved state list. The Region 15 Music Chairperson will solicit the input of Region 15 music teachers in the selection of the adjudicators.
2. Two adjudicators will be used for band and orchestra, and two for choirs. One other adjudicator will be selected to judge orchestras and will be paid the current rate for one-half day only.
3. All adjudicators will be compensated for their time and mileage according to the current UHSAA rate. Those traveling more than three hours will be offered lodging and two meals.
4. The location of the Festival will be selected annually by the Region Board of Directors.
5. Individuals in each group (band, orchestra, and choir) will receive a certificate reflecting ratings of I- or better.
6. All other rules and guidelines will follow the current UHSAA Handbook.

### **SMALL GROUPS MUSIC FESTIVAL**

1. Rules and guidelines of the Utah High Schools Activities Association as printed in the current UHSAA Handbook will be followed.
2. Entries must be submitted on the appropriate UHSAA forms. The information must be typed and signed. "FAX" copies are NOT acceptable.
3. Seven official categories will be recognized and judged: woodwinds, brass, strings, piano, vocal/choral, and jazz. Students wishing to perform in other categories may do so, but they will be judged by those chosen for the above-mentioned categories. Points earned in categories other than those six named will not count toward the Region Sweepstakes trophy.
4. The Region Music Festival Chairperson will arrange for the adjudicators each year. The chairperson will ensure that the adjudicators have access to copies of the state published bulletin, "Better Adjudication in Utah."
5. Additional rules for the festival include:
  - A. All school entries must confirm to UHSAA rules and guidelines.
  - B. Schools will have unlimited entries in each event.
6. AWARDS - Students earning an I-Rating or higher will receive a certificate reflecting that rating.

### **LARGE GROUP MUSIC FESTIVAL**

In addition to the Rules and Regulations published by the UHSAA Handbook, the following guidelines will further give directions with regard to the Large Group Music Festival:

1. The large Group Music Festival will allow students to demonstrate experiences and skills learned throughout the course of the year. Students need to be motivated in such a way as to promote the

- Festival as the culminating activity of the year.
2. All participating orchestras, choirs, and bands must be regular classes in the school's curriculum. Split groups of choruses will not be accepted as participants.
  3. A total band, choir, or orchestra may not participate as a group in both Small and Large Group Festivals.
  4. The order of performance of bands, orchestras, and choirs will be determined by the Music Chairperson two weeks prior to the Festival.
  5. All groups are encouraged to remain at the festival throughout. Adjudication sheets will be distributed after all groups have performed.
  6. Schools are responsible for the behavior of their own students. Please ensure that they do not disturb host school classes, etc. Much can be gained from the performance of other schools; therefore students are encouraged to be in attendance. While as a member of the audience, students may jeopardize their own school's ratings through inappropriate behavior.
