TICKET PRICES & SPECTATOR ADMISSION

Very limited spectator seating will be available. Ticket offices will open 60 minutes prior to the competition start time. Limited pass holder tickets will be available from the ticket office. The ticket price for all State Drill Competitions is \$10. The 3A-4A-5A-6A participating schools will receive a block of pre-sale tickets for both semifinal and final competitions. Each school must distribute the tickets to their spectators. Schools will be invoiced and responsible to sell all pre-sell tickets. 2A schools will receive vouchers for spectators to purchase tickets at the SVC. Any 2A vouchers that are not redeemed will be available for purchase at noon on February 6th.

Spectators will not be allowed to enter the arena until the arena has been cleared from the previous pod. The earliest doors will open will be 1 hour prior to each event. Spectators will be required to sit in assigned reserve seats. **No overnight camping will be allowed at UVU. Spectators will be required to wear a mask face that covers the nose and mouth while in the arena.**

PLEASE NOTE THAT THE ARENA WILL BE CLEARED FOLLOWING EACH SEMIFINAL POD AND FINAL EVENT.

TEAM DROP-OFF, CHECK-IN & ARENA SEATING

Coaches shall provide their driver with the map of the drop-off route posted on the Drill page at www.uhsaa.org. For UVU competitions:

Buses must follow the designated route through the UVU parking lot to the team drop-off area by the entrance to the North Back Service Lot ([see map](#)). TEAMS SHALL WALK DOWN THE RAMP ON THE NORTH SIDE OF THE UCCU CENTER AND CHECK-IN AT THE NORTH ENTRANCE (the large garage door on the north side). Bus parking will be available at UVU West Campus in Lot 1. No bus driver seating will be available at UVU.

Parking and transportation guidelines are located on the Drill page from the UHSAA website.

Large props may be dropped off by the service entrance on the North side where teams enter. No parking of vehicles or trailers in the back parking lot.

For the 2A competition at the SVC:

Buses should drop off participants at the North team entrance. See the map on the UHSAA Drill page at www.uhsaa.org for information on bus parking. Teams should enter under the sign for participant's entrance.

Please come prepared knowing the number of team members you have, as this information is needed for the check-in process. After dropping off the team, buses proceed north out of the parking and follow the designated route as outlined on the map. Coaches shall have their team check-in as a group to have their hands stamped for the day. **Teams may not check in prior to their assigned check-in time. Teams can check-in at the following times:**

With limited seating for spectators, teams will not be allowed to sit in the arena. Team members will NOT be allowed to sit or leave items in the spectator seating area prior to the competition starting or during the competition. For the Final competition day, teams will be assigned an area to sit during the announcement of awards. DUE TO COVID-19 RESTRICTIONS NO DRILL DOWN EVENT WILL BE HELD AT THE STATE COMPETITION.

TEAM DRESSING AREAS & COSTUME STORAGE

Each team will be provided an area for costume changes. These are not secure areas, so do not leave possessions unattended. Mirrors and plugs will be limited so please come prepared. Do not leave curling irons unattended at any time. Remember that this is just a curtain area as well as a walkway, so please dress in the dressing rooms and do not leave any valuables unattended.

At UVU: Do not plug curling irons into the hallway outlets near their offices. There are two restrooms in the west tunnel and one locker room for use by drill team members. It will be Locker Room 6. This is NOT a team area. This locker room is for restroom purposes only and will be strictly monitored. Any team taking advantage of the use of this locker room may receive a **sportsmanship penalty**. The costume storage area will consist of pipe and drape with chairs inside of the area. Locker rooms will **not** be available for teams.

OUTSIDE FOOD

UCCU and SVC do not allow outside food in their arenas. However, teams will be allowed to bring no more than two coolers to provide nourishment for the athletes. Teams can eat at the concessions level or in an area outside the arena. PLEASE, NO CROCKPOTS!!

CERTIFIED COACHES

Only coaches who are certified through Register My Coach will be allowed on the floor at UVU. Credentials must be worn to gain access to the competition area.

UVU TRAINER ON STAFF

A certified UVU trainer will be on staff 30 minutes prior to the start of the competition. The UVU training room is in the east tunnel on arena floor level. At the SVC a trainer will be located in the south-west corner of the arena. Ice is available if needed for treatment of injuries.

ENTRANCE, EXIT and PERFORMANCE INSTRUCTIONS

The order of performance will be **Military, Dance and Show**. **ALL TEAMS MUST ENTER & EXIT FROM THE NORTH END OF THE FLOOR (NO EXCEPTIONS)**. Penalties will be assessed for entering and exiting the floor from the wrong direction. Coaches are responsible for compliance to all safety rules including jewelry, fingernails, etc.

- **Please see the “Order of Performance” to determine the direction each school will face for each competition.**

ROTATION FOR TEAMS TO FOLLOW

The rotation of the day will be as follows: Teams will go from the dressing area, to the warm-up area, to the hall outside the arena, to line-up off the floor, to the performance floor. Teams should only line up off the floor one team before they are called to the floor. Masks should be worn by all participants until they are lined up one team prior to entering the floor. Coaches should collect the masks while they are lined up to perform. Masks should be worn in the venue by all participants, except while they are actively performing.

Teams are responsible to go to the practice area on their own. Teams must be ready to perform at their designated time or risk receiving a penalty according to UHSAA rules. It is the responsibility of the coach to have their team in proper place at the proper time, so they do not miss their rotation onto the performing floor.

Only participants, certified and credentialed coaches, officials and tournament staff are allowed on the floor level.

When teams have finished competing on the semifinal day, remove all belongings from the dressing area and leave the arena immediately. Failure to do so will result in a sportsmanship penalty. As soon as the last team has performed for the day and the announcement of the 8 finalist teams are made, score sheets will be available at the table in the Southeast corner of the arena. One coach may collect the scoresheets. A draw for Order of Performance will be done following the announcement of teams moving on to the Finals in Presidential South.

MUSIC

There will be NO music check the day of the event.

During the competition, a credentialed coach must be at the sound table ready to cue the music as the team enters the floor. Failure to do so, will result in a team being penalized. **Teams must have a representative at the table to start the music and to notify the sound technician immediately if there are any technical difficulties.** There will be three chairs set up on the opposite side of the floor from the sound table for the coaches whose teams are performing WEST to sit and watch their team. **These seats are for credentialed coaches only.**

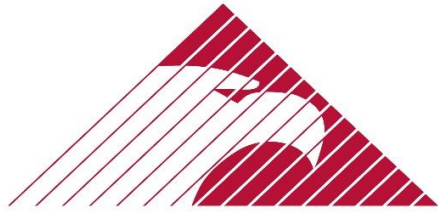
SPORTSMANSHIP RULE (See Drill Section of the UHSAA Handbook)

Unsportsmanlike conduct by drill team members or coaches during the competition will result in a 2-point penalty per routine judge for each violation. If unsportsmanlike conduct is committed during the competition, a written complaint must be submitted to the competition director within the time frame of the current competition category. Any member of the UHSAA Tournament Committee may assess these points. The points would be deducted before the ranking scores are given and would be assessed to routine category being performed nearest the infraction. A sportsmanship penalty may be assessed to any team who changes costumes inside of the performance arena.

VIDEOTAPING FOR COMMERCIAL USE IS PROHIBITED
