## 2021-22 UHSAA SOLO & ENSEMBLE FESTIVALS Eligibility Requirements for Festival Participation

**PRIOR TO PARTICIPATION** in a Region Solo & Ensemble Festival, the principal and music director(s) shall review the eligibility requirements listed below. The form requires a signature from the principal and music director(s) after the eligibility of the participating students have been verified. Submit the completed form to the UHSAA office prior to participation in a Region Solo & Ensemble Festival, **BUT NO LATER THAN THE DEADLINE OF MARCH 1.**

### 1. Schools Shall Adhere to UHSAA Festival Guidelines

- A. Music Directors shall adhere to UHSAA festival guidelines outlined in the *UHSAA Handbook Music Section*, available at [www.uhsaa.org](http://www.uhsaa.org) under the Publications tab or on the Music page.
- B. By the region deadline, entries to the Region Solo & Ensemble Festival shall be submitted by the school music director to the Region Festival Host/Scheduler on the UHSAA Region Solo & Ensemble Entry Form (Music page at uhsaa.org).
- C. Only soloists and ensembles receiving superior ratings (I) at the region festival and correctly nominated by a region festival adjudicator may participate in the State Solo & Ensemble Festival. A (I-) is not acceptable. Any entry receiving a Superior (I) is eligible to participate in the State S & E Festival except for piano. Piano entries are limited to one entry multiplied by the number of schools in the region.
- D. **Regions are assigned to participate in the following state festival locations:**
- E. **NORTH Solo & Ensemble Festival at Northridge High School**  
Regions 1, 2, 3, 5, 6, 10, 11, 13, 15, 16, 17 & 22, including Alta HS and Mountain Ridge HS  
**SOUTH Solo & Ensemble Festival at Orem High School**  
Regions 4, 7, 8, 9, 12, 14, 16, 18, 19, 20 & 21, including Cedar Valley HS, Wasatch Academy and Waterford
- F. Entries to the State Solo & Ensemble Festival shall be submitted by the Region Music Chair to the State Festival Director by Friday, April 6, 2012. The entries should be submitted on the UHSAA State Solo & Ensemble Entry Form (Music page at uhsaa.org). Responsibilities of school directors are listed in the *UHSAA Handbook Music Section*.
- G. Schools will be charged a fee of \$25 for each "no show" or canceled performance that occurs after the Monday prior to the State Festival. A tentative festival schedule will be posted two weeks prior for music directors to review.
- H. Scheduling requests and any protests or grievances regarding any results MUST come from the school's music director. This must be submitted, in writing, to the **festival director**. Scheduling requests and grievances from students or parents will **NOT** be considered.

### 2. Schools Shall Comply with U.S. Music Copyright Laws & Guidelines

Students and school music directors have a responsibility to adhere to and be in compliance with the existing U.S. Copyright Laws & Guidelines when performing copyrighted materials. Information is available on the Music page at [www.uhsaa.org](http://www.uhsaa.org). According to the *UHSAA Handbook Music Section, II-C: The use of photocopied or otherwise reproduced copies of published music must comply with the United States Copyright Law. Participants shall either provide the original score or written permission from the copyright owners to duplicate the music. If an unauthorized reproduction of published music is used an adjudicator may give a "no rating."*

### 3. Schools Shall Verify Eligibility Prior to Participation

- A. Students must be eligible according to UHSAA standards in order to participate in a Region or State Solo & Ensemble Festival (*UHSAA Handbook, Article 1 Section 8 and Music Section*).
- B. After verifying the eligibility of the students, the school principal and the school music director(s) shall sign on the lines provided below. Multiple lines are provided for the schools that several vocal and instrumental teachers.

*We hereby attest that the eligibility of the students have been verified and only those that meet the UHSAA standards of eligibility will be allowed to perform at a Region Solo & Ensemble Festival or the State Solo & Ensemble Festival.*
